

## New View Customer Referral Program

### Rules and Regulations

1. Any purchase made must be for product with installation. Rewards are not offered for supplied/over counter sales. 2. The referred customer must be an individual or business with whom you have a pre-existing relationship. You may not obtain names for referrals from group email addresses, third party bulk mailing lists, customer lists, or other similar sources. You may not send unsolicited e-mails ("Spam"). If you send spam, New View may immediately and permanently revoke your eligibility to receive rewards in this or any other program offered. The referred customer must be of "unique" status. A "unique" status as defined for this program is any person referred who is not a previous customer of New View, or has had any contact with New View for any reason.
